Multiple Positive Solutions of Nonlinear Boundary Value Problem for Finite Fractional Difference

We consider a discrete fractional nonlinear boundary value problem in which nonlinear term f is involved with the fractional order difference. And we transform the fractional boundary value problem into boundary value problem of integer order difference equation. By using a generalization of Leggett-Williams fixed-point theorem due to Avery and Peterson, we provide sufficient conditions for the existence of at least three positive solutions.

1. Introduction

Let \mathbb{R} and \mathbb{Z} be the sets of real numbers and integers, respectively. For $a, b \in \mathbb{R}$, $N \in \mathbb{Z}^+$ with b = a + N, define $[a,b]_{\mathbb{N}_a} = \{a, a + 1, \dots, b\}$. Assume that *T* is a given positive integer with T > 2. We consider the fractional difference boundary value problem (briefly FBVP) of the forms

where $\eta \in [0, 1]$, $\nu, \beta, \varepsilon, \delta \in (0, 1)$ with $\beta, \delta \leq \nu \leq \varepsilon$, and $\varphi_p(s) = |s|^{p-2}s$, p > 1, $\xi \in [0, T]_{\mathbb{N}_0}$, $\Delta_{\nu-1}^{\varrho}$ ($\varrho = \nu, \beta, \varepsilon, \delta$) is fractional difference operator. We give the following assumptions:

- (*H*1) $f(t+\nu-1,\cdot,\cdot): [\nu-1,T+\nu-1]_{\mathbb{N}_{\nu-1}} \times [0,+\infty) \times \mathbb{R} \rightarrow [0,+\infty)$ is continuous;
- (*H*2) q(t) is nonnegative on $[0, T]_{\mathbb{N}_0}$, $q(t) \equiv 0$ does not hold on $[0, T]_{\mathbb{N}_0}$, and $\sum_{t=0}^T q(t) < \infty$.

Fixed-point theorems and their applications in nonlinear problems have a long history, some of which are documented in Zeidler's book [1]. There seems to be increasing interest in multiple fixed-point theorems and their applications to boundary value problems for ordinary differential equations or finite difference equations. The applications can be found in the papers [2-6]. An interest in triple solutions has evolved from the Leggett-Williams multiple fixed-point theorem [7]. And, lately, two triple fixed-point theorems by Avery and Peterson [4] and Avery [8] have been applied to obtain triple solutions of certain boundary value problems for ordinary differential equations as well as for their discrete analogues. On the other hand, fractional differential and difference "operators" are found themselves in concrete applications, and hence attention has to be paid to associated fractional difference and differential equations under various boundary or side conditions. For example, Atici and Eloe [9] explored some of the theories of a discrete conjugate FBVP in [9]. Similarly, in [10], a discrete right-focal FBVP was analyzed. Other recent advances in the theory of the discrete fractional calculus may be found in [11-26]. In particular, an interesting recent paper by Atici and Şengül [14] addressed the use of fractional difference equations in tumor growth modeling. Thus, it seems that there exists some promise in using fractional difference equations as mathematical models for describing physical problems in more accurate manners.

In order to handle the existence problem for FBVP, various methods (among which are some standard fixedpoint theorems) can be used. For example, in [10, 12, 27], authors investigated the existence to some boundary value problems by fixed-point theorems on a cone. In [28], we established the existence conditions for a boundary value problem by using the coincidence degree theory. In [29], authors pointed out the existence of multiple solutions for a FBVP with parameter by establishing the corresponding variational framework and using the mountain pass theorem, linking theorem, and Clark theorem in critical point theory. To the best of our knowledge, Leggett-Williams fixed-point theorem has not been used in discrete fractional boundary value problems. The aim of this paper is to establish the existence conditions for boundary value problem (1)-(2). The proof relies on the Leggett-Williams fixed-point theorem.

Throughout this paper, we make the convention that $\sum_{i=i}^{m} x(i) = 0$ for m < j and denote $\varphi_q = \varphi_p^{-1}$, 1/p + 1/q = 1.

2. Preliminaries

In this section, we collect some basic definitions and lemmas for manipulating discrete fractional operators. These and other related results can be found in [4, 12, 14, 16].

For any integer β , let $\mathbb{N}_{\beta} = \{\beta, \beta + 1, \beta + 2, ...\}$. We define $t^{(\nu)} := \Gamma(t+1)/\Gamma(t+1-\nu)$, for any *t* and *v* for which the right-hand side is defined. We also appeal to the convention that if $t + 1 - \nu$ is a pole of the Gamma function and t + 1 is not a pole, then $t^{(\nu)} = 0$.

Definition 1. The *v*th fractional sum of f for v > 0 is defined by

$$\Delta_{a}^{-\nu}f(t) = \frac{1}{\Gamma(\nu)} \sum_{s=a}^{t-\nu} (t-s-1)^{(\nu-1)} f(s), \qquad (3)$$

for $t \in \mathbb{N}_{a+\nu}$. We also define the ν th fractional difference for $\nu > 0$ by $\Delta_a^{\nu} f(t) := \Delta^N \Delta_a^{\nu-N} f(t)$, where $t \in \mathbb{N}_{a+N-\nu}$, and $N \in \mathbb{N}$ is chosen so that $0 \le N - 1 < \nu \le N$.

Definition 2. Let X be a real Banach space. A nonempty closed convex set $P \subset X$ is called a cone of X if it satisfies the following conditions:

- (1) $x \in P, \lambda \ge 0$ implies $\lambda x \in P$;
- (2) $x \in P, -x \in P$ implies x = 0.

Every cone $P \in X$ induces a partial ordering " \leq " on X defined by $x \leq y$ if and only if $y - x \in P$.

Definition 3. Given a cone *P* in a real Banach space \mathbb{X} , a functional $\psi : P \to \mathbb{R}$ is said to be increasing on *P*, provided that $\psi(x) \le \psi(y)$ for all $x, y \in P$ with $x \le y$.

Let γ and θ be nonnegative continuous convex functionals on P, α a nonnegative continuous concave functional on P, and ψ a nonnegative continuous functional on P. Then, for positive real numbers a, b, c, and d, we define the following convex sets:

$$P(\gamma, d) = \{x \in P \mid \gamma(x) < d\},\$$

$$P(\gamma, \alpha, b, d) = \{x \in P \mid b \le \alpha(x), \gamma(x) \le d\},\$$

$$P(\gamma, \theta, \alpha, b, c, d) = \{x \in P \mid b \le \alpha(x), \theta(x) \le c, \gamma(x) \le d\},\$$

$$d\} \text{ and a closed set } R(\gamma, \psi, a, d) = \{x \in P \mid a \le \psi(x), \gamma(x) \le d\}.$$

The following fixed-point theorem due to Avery and Peterson is fundamental in the proof of our main results.

Lemma 4 (see [4]). Let X be a Banach space and let $P \in X$ be a cone. Let γ and θ be nonnegative continuous convex functionals on P, α a nonnegative continuous concave functional on P, and ψ a nonnegative continuous functional on P satisfying $\psi(\lambda x) \leq \lambda \psi(x)$ for $0 \leq \lambda \leq 1$, such that, for some positive numbers M and $d, \alpha(x) \leq \psi(x)$ and $||x|| \leq M\gamma(x)$ for all $x \in \overline{P(\gamma, d)}$. Suppose $Q : \overline{P(\gamma, d)} \to \overline{P(\gamma, d)}$ is completely continuous and there exist positive numbers a, b, c with a < bsuch that

- (S1) { $x \in P(\gamma, \theta, \alpha, b, c, d) \mid \alpha(x) > b$ } $\neq \emptyset$ and $\alpha(Qx) > b$ for $x \in P(\gamma, \theta, \alpha, b, c, d)$;
- (S2) $\alpha(Qx) > b$ for $x \in P(\gamma, \alpha, b, d)$ with $\theta(Qx) > c$;
- (S3) $0 \notin R(\gamma, \psi, a, d)$ and $\psi(Qx) < a$ for $x \in R(\gamma, \psi, a, d)$ with $\psi(x) = a$.

Then Q has at least three fixed points $x_1, x_2, x_3 \in \overline{P(\gamma, d)}$ such that

 $b < \alpha(x_1), \psi(x_3) < a, a < \psi(x_2) \text{ with } \alpha(x_2) < b.$

Lemma 5 (see [16]). Let $y : \mathbb{N}_a \to \mathbb{R}$ and v > 0 with $N - 1 < v \le N$, and then

$$\Delta_{a}^{\nu} y(t) = \sum_{k=0}^{t-a+\nu} (-1)^{k} {\nu \choose k} y(t+\nu-k), \qquad (4)$$

for $t \in \mathbb{N}_{a+N-\nu}$, where $\binom{\nu}{k} = \Gamma(\nu+1)/\Gamma(k+1)\Gamma(\nu-k+1)$.

Lemma 6 (see [16]). Let $f : \mathbb{N}_a \to \mathbb{R}$ be given and suppose $k \in \mathbb{N}_0$ and $\nu > 0$. Then, for $t \in \mathbb{N}_{a+\nu}$,

$$\Delta_{a}^{-\nu} \Delta^{k} f(t) = \Delta_{a}^{k-\nu} f(t) - \sum_{j=0}^{k-1} \frac{\Delta^{j} f(a)}{\Gamma(\nu - k + j + 1)} (t - a)^{(\nu - k + j)} .$$

Moreover, if $\mu > 0$ with $M - 1 \le \mu \le M$, then, for $t \in \mathbb{N}_{a+M-\mu+\nu}$,

$$\Delta_{a+M-\mu}^{-\nu} \Delta_{a}^{\mu} f(t) = \Delta_{a}^{\mu-\nu} f(t) - \sum_{j=0}^{M-1} \frac{\Delta_{a}^{j-M+\mu} f(a+M-\mu)}{\Gamma(\nu-M+j+1)}$$

Lemma 7 (see [16]). Let $f : \mathbb{N}_a \to \mathbb{R}$ be given and suppose $\mu, \nu > 0$ with $N - 1 < \mu \leq N$. Then, for $t \in \mathbb{N}_{a+\nu+N-\mu}$,

$$\Delta^{\mu}_{a+\nu}\Delta^{-\nu}_{a}f(t) = \Delta^{\mu-\nu}_{a}f(t).$$

Lemma 8 (see [16]). Let $f : \mathbb{N}_a \to \mathbb{R}$ be given and suppose $\nu > 0$ with $N - 1 < \nu < N$. Then, for $t \in \mathbb{N}_{a-\nu+N}$,

$$\Delta_{a}^{\nu} f(t) = \begin{cases} \frac{1}{\Gamma(-\nu)} \sum_{s=a}^{t+\nu} (t-s-1)^{(-\nu-1)} f(s), & N-1 < \nu < N; \\ \Delta^{N} f(t), & \nu = N. \end{cases}$$

Lemma 9 (see [16]). Let $a \in \mathbb{R}$ and $\mu > 0$ be given. Then,

$$\Delta (t-a)^{(\mu)} = \mu (t-a)^{(\mu-1)}, \qquad (9)$$

for any t for which both sides are well-defined. Furthermore, for $\nu > 0$,

3. Triple Positive Solutions

In this section, we impose growth conditions on f to obtain the triple positive solutions for FBVP (1)-(2).

For the sake of convenience, for $0 < \delta \leq \nu \leq \varepsilon, \xi \in$ $[0, T]_{\mathbb{N}_0}, \eta \in [0, 1], p > 1$, we set the following notations:

Then, from (11), we immediately obtain some properties of $\kappa(t, \varrho)$ as follows:

$$\kappa(t,\varrho) \in \begin{cases} \{1\}, & (t,\varrho) \in \{-2\} \times (0,1), \\ (0,1), & (t,\varrho) \in [-1,T]_{\mathbb{N}_{-1}} \times (0,\nu), \\ \{0\}, & (t,\varrho) \in [-1,T]_{\mathbb{N}_{-1}} \times \{\nu\}, \\ (-1,0), & (t,\varrho) \in [-1,T]_{\mathbb{N}_{-1}} \times (\nu,1). \end{cases}$$

We will also need the following elementary facts:

Indeed, if $\delta \leq \nu = \varepsilon$, then, by (12) and (14), clearly, $\tau = 0$. If $\delta = \nu < \varepsilon$, then

$$\begin{aligned} \tau &= \left(-\sum_{s=0}^{T} \kappa \left(T - s - 1, \varepsilon \right) - \eta \kappa \left(T, \varepsilon \right) \right) \\ &= 1 - \sum_{s=0}^{T+1} k \left(T - s - 1, \varepsilon \right) - \eta \kappa \left(T, \varepsilon \right) \\ &= 1 - \frac{1}{\Gamma \left(\nu - \varepsilon \right)} \sum_{s=0}^{T+1} \left(T + \nu - \varepsilon - s \right)^{\left(\nu - \varepsilon - 1 \right)} - \eta \kappa \left(T, \varepsilon \right) \\ &= 1 - \left(1 + \left(\nu - \varepsilon \right) + \frac{\left(1 + \nu - \varepsilon \right) \left(\nu - \varepsilon \right)}{2!} \right) \\ &+ \cdots + \frac{\left(T + \nu - \varepsilon \right) \cdots \left(\nu - \varepsilon \right)}{\left(T + 1 \right)!} \right) - \eta \kappa \left(T, \varepsilon \right) \\ &= 1 - \left(\left(1 + \nu - \varepsilon \right) \left(1 + \frac{\nu - \varepsilon}{2} \right) + \frac{\left(2 + \nu - \varepsilon \right) \cdots \left(\nu - \varepsilon \right)}{3!} \right) \\ &+ \cdots + \frac{\left(T + \nu - \varepsilon \right) \cdots \left(\nu - \varepsilon \right)}{\left(T + 1 \right)!} \right) - \eta \kappa \left(T, \varepsilon \right) \\ &= 1 - \left(\frac{\left(1 + \nu - \varepsilon \right) \left(2 + \nu - \varepsilon \right)}{2!} \left(1 + \frac{\nu - \varepsilon}{3} \right) \\ &+ \cdots + \frac{\left(T + \nu - \varepsilon \right) \cdots \left(\nu - \varepsilon \right)}{\left(T + 1 \right)!} \right) - \eta \kappa \left(T, \varepsilon \right) \\ &= \cdots \\ &= 1 - \left(\frac{\left(T + 1 + \nu - \varepsilon \right) \left(T + \nu - \varepsilon \right) \cdots \left(1 + \nu - \varepsilon \right)}{\left(T + 1 \right)!} \right) \\ &- \eta \frac{\left(T + 1 + \nu - \varepsilon \right) \left(T + \nu - \varepsilon \right) \cdots \left(1 + \nu - \varepsilon \right)}{\left(T + 1 \right)!} \\ &= 1 - \left(\frac{\left(T + 1 + \nu - \varepsilon \right) \left(T + \nu - \varepsilon \right) \cdots \left(1 + \nu - \varepsilon \right)}{\left(T + 1 \right)!} \right) \end{aligned}$$

It follows that $0 < \tau < 1$.

If $\delta < \nu < \varepsilon$, then, since

Now, suppose that y(t) is a solution of (20)–(22). We will show that

Next, let $B = \{y : [0, T + 2]_{\mathbb{N}_0} \to \mathbb{R}\}$ be endowed with the norm $||y|| = \max\{||y||_{\infty}, ||\Delta y||_{\infty}\}$, where $||y||_{\infty} = \max_{t \in [0, T+2]_{\mathbb{N}_0}} |y(t)|$. Choose the cone $P \in B$ defined by

We next require a preliminary lemma.

- (iii) $Q: P \rightarrow P$ is completely continuous;
- (iv) finding positive solutions of FBVP (20)–(22) is equivalent to finding fixed points of the operator Q on P;
- (v) If $y \in P, y(t) \ge (t/(T+2)) \|y\|_{\infty} = (t/(T+2)) y(T+2),$ for $t \in [0, T+2]_{\mathbb{N}_0}$.

The proof is simple and omitted.

By Lemma 10 and (33), for all $y \in \overline{P(\gamma, d)} \subset P$, the functionals defined above satisfy

$$(H6) \ L = ((M_2 + M_3)/Nk) + \eta(\varepsilon - \nu) \sum_{s=0}^{\xi+1} \kappa(\xi - s - 1, \delta) + (\varepsilon - \nu)(T+2) \le 1.$$

Then FBVP (1)-(2) has at least three positive solutions x_1, x_2 , and x_3 satisfying

Proof. By the definition of operator Q and its properties (i)–(v), it suffices to show that the conditions of Lemma 4 hold with respect to Q.

Firstly, if $y \in P(\gamma, d)$, we know $\gamma(y) = \max_{t \in [0, T+1]_{\mathbb{N}^n}} |\Delta y(t)| \le d$. From (37), we have

Thus, assumption (H3) and Lemma 10 imply that

$$\begin{split} \psi\left(Qy\right) &= \max_{t\in[0,T+2]_{N_0}} \left| \left(Qy\right)\left(t\right) \right| \\ &\leq \frac{\eta}{1-\eta\kappa\left(\xi,\delta\right)} \sum_{s=0}^{\xi+1} \kappa\left(\xi-s-1,\delta\right) \varphi_q \\ &\cdot \left(\sum_{j=s}^T q\left(j\right) f\left(j+\nu-1,x\left(j+\nu-1\right), \frac{1}{j+\nu-\beta} \Delta_{\nu-1}^{\beta} x\left(j\right)\right) \right) \\ &+ \varphi_p\left(\left(\varepsilon-\nu\right)a\right) \right) \\ &+ \sum_{i=0}^{T+1} \varphi_q\left(\sum_{j=i}^T q\left(j\right) f\left(j+\nu-1,x\left(j+\nu-1\right), \frac{1}{j+\nu-\beta} \Delta_{\nu-1}^{\beta} x\left(j\right)\right) \\ &+ \varphi_p\left(\left(\varepsilon-\nu\right)a\right) \right) \\ &\leq \frac{\eta}{1-\eta\kappa\left(\xi,\delta\right)} \sum_{s=0}^{\xi+1} \kappa\left(\xi-s-1,\delta\right) \varphi_q \\ &\cdot \left(\sum_{j=s}^T q\left(j\right) \varphi_p\left(\frac{a}{Nk}\right) + \varphi_p\left(\left(\varepsilon-\nu\right)a\right)\right) \end{split}$$

$$= \frac{\eta}{1 - \eta \kappa (\xi, \delta)} \sum_{s=0}^{\xi+1} \kappa (\xi - s - 1, \delta)$$

$$\cdot \left(\left(\left(\sum_{j=s}^{T} q(j) \right)^{1/(p-1)} \frac{a}{Nk} + (\varepsilon - \nu) a \right) \right)$$

$$+ \sum_{i=0}^{T+1} \left(\left(\left(\sum_{j=s}^{T} q(j) \right)^{1/(p-1)} \frac{a}{Nk} + (\varepsilon - \nu) a \right) \right)$$

$$\leq \frac{aM_{2}}{Nk} + \frac{\eta (\varepsilon - \nu)}{1 - \eta \kappa (\xi, \delta)} \sum_{s=0}^{\xi+1} \kappa (\xi - s - 1, \delta) a + \frac{aM_{3}}{Nk}$$

$$+ (T + 2) (\varepsilon - \nu) a$$

$$\leq \left(\frac{M_{2} + M_{3}}{Nk} + \frac{\eta (\varepsilon - \nu)}{1 - \eta \kappa (\xi, \delta)} \right)$$

$$\cdot \sum_{s=0}^{\xi+1} \kappa (\xi - s - 1, \delta) + (T + 2) (\varepsilon - \nu) \right) a$$

$$\leq a.$$

Case ii. Consider $1 . By (H5)–(H6) and the inequality <math>(x + y)^{p-1} - y^{p-1} \ge (p-1)(x + y)^{p-2}x$, for $x, y \in \mathbb{R}^+$, we can have

$$\begin{split} \psi\left(Qy\right) &= \max_{t \in [0, T+2]_{\mathbb{N}_{0}}} \left| \left(Qy\right)(t) \right| \\ &\leq \frac{\eta}{1 - \eta\kappa\left(\xi, \delta\right)} \sum_{s=0}^{\xi+1} \kappa\left(\xi - s - 1, \delta\right) \\ &\cdot \left(\sum_{j=s}^{T} q\left(j\right)\right)^{1/(p-1)} \varphi_{q}\left(f\left(j + \nu - 1, x\left(j + \nu - 1\right), \right. \\ &\left. \left. \left. \right. \right. \right)^{j+\nu-\beta} \Delta_{\nu-1}^{\beta} x\left(j\right) \right) \\ &+ \varphi_{p}\left((\varepsilon - \nu) a\right) \frac{1}{\sum_{j=s}^{T} q\left(j\right)} \right) \\ &+ a \sum_{i=0}^{T+1} \left(\sum_{j=i}^{T} q\left(j\right)\right)^{1/(p-1)} \varphi_{q}\left(f\left(j + \nu - 1, x\left(j + \nu - 1\right), \right. \\ &\left. \right. \right)^{j+\nu-\beta} \Delta_{\nu-1}^{\beta} x\left(j\right)\right) \end{split}$$

So, condition (S3) of Lemma 4 is satisfied. Therefore, Lemma 4 implies that the FBVP (20)–(22) has at least three

positive solutions y_1 , y_2 , and y_3 satisfying (38); that is, the FBVP (1)-(2) has at least three positive solutions x_1 , x_2 , and x_3 satisfying (38). The proof is complete.

Theorem 12. Let $\delta \le v = \varepsilon$ and (H1)–(H4) hold. In addition, assume that the following condition is satisfied:

(H7)
$$f \le \varphi_p(a/(M_2 + M_3)).$$

Then the FBVP (1)-(2) has at least three positive solutions x_1, x_2 , and x_3 satisfying (38).

Proof. If $\varepsilon = v$, (21) is equivalent to $\Delta y(T + 1) = 0$ by (14). Similar to discussion in Theorem 11, we know that (24) holds.

For $t \in [0, T+2]_{\mathbb{N}_0}$, define an operator $Q: P \to B$ by

$$Qy(t) = \frac{\eta}{1 - \eta\kappa(\xi, \delta)} \sum_{s=0}^{\xi+1} \kappa(\xi - s - 1, \delta) \varphi_q$$

$$\cdot \left(\sum_{j=s}^T q(j) \right)$$

$$\cdot f(j + \nu - 1, x(j + \nu - 1), _{j+\nu-\beta} \Delta_{\nu-1}^{\beta} x(j)) \right)$$

$$+ \sum_{i=0}^{t-1} \left(\varphi_q \left(\sum_{j=i}^T q(j) \right)$$

$$\cdot f(j + \nu - 1, x(j + \nu - 1), _{j+\nu-\beta} \Delta_{\nu-1}^{\beta} x(j)) \right) \right).$$
(48)

The rest of the proof is similar to Theorem 11, so it is omitted. The proof is complete. $\hfill \Box$

Example 13. Consider the boundary value problem:

$$\Delta \left(\varphi_{p}\left(\Delta_{-0.05}^{0.95}x\left(t\right)\right)\right) + f\left(t + \nu - 1, x\left(t + \nu - 1\right), {}_{t+0.05}\Delta_{-0.05}^{0.9}x\left(t\right)\right) = 0, \quad t \in [0, 10]_{\mathbb{N}_{0}}, \quad (49)$$
$$\left[\Delta_{-0.05}^{0.96}x\left(t\right)\right]_{t=10.99} = 0, \quad x\left(-0.05\right) = \frac{1}{2}\left[\Delta_{-0.05}^{0.94}x\left(t\right)\right]_{t=2.01}.$$

Compared with (1), we have q(t) = 1, p = 3, q = 3/2, $\xi = 1$, T = 10, $\nu = 0.95$, $\beta = 0.9$, $\varepsilon = 0.96$, $\delta = 0.94$, $\eta = 1/2$, h = 6, and

$$f\left(t+\nu-1,u,\nu\right)$$

$$=\begin{cases} |\sin(t+\nu-1)|+49+\frac{\nu}{1500}, & 0 \le u \le 500; \\ |\sin(t+\nu-1)|+49 & & (50) \\ +\frac{1}{11.5}(u-500)^2+\frac{\nu}{1500}, & 500 \le u \le 1000; \\ |\sin(t+\nu-1)|+49 & & \\ +\frac{1}{11.5}(500)^2+\frac{\nu}{1500}, & u \ge 1000. \end{cases}$$

Then, FBVP (49) has at least three positive solutions.

Proof. Choose a = 500, b = 1800, d = 5000, p = 3, q = 3/2, and k = 2.

By computation, we know $\tau \approx 0.0021$, $M_1 \approx 11$, $M_2 \approx 1.56$, $M_3 = \sum_{j=0}^{10} (11 - j)^{1/2} \approx 25.78$, $N = M_3$, and $m \approx 0.52$. It is easy to see that 0 < a < b < 2d. And f satisfies that

$$f(t + \nu - 1, u, \nu)$$

$$\leq 50 + \frac{250000}{11.5} + \frac{62590.21}{1500} \approx 21830.21 \qquad (51)$$

$$< 2270663.03 \approx \frac{1}{M_1} \varphi_p(d),$$

for $(t, u, v) \in [0, 10]_{\mathbb{N}_0} \times [0, 62590.21] \times [0, 62590.21];$

$$f(t + \nu - 1, u, \nu)$$

$$\geq 49 + \frac{500^2}{11.5} \approx 21788 > 19488 \qquad (52)$$

$$\approx \left(\frac{3600}{25.78}\right)^2 = \varphi_p\left(\frac{(T+2)b}{hM_3}\right),$$

for $(t, u, v) \in [6, 10]_{\mathbb{N}_0} \times [1800\Gamma(10 + v)/\Gamma(11)\Gamma(v), 3600] \times [0, 62590.21];$

$$f(t + v - 1, u, v) < 50 + \frac{62590.21}{1500} \approx 91.73$$
$$\leq \left(\frac{500}{2 \times 25.78}\right)^2 < 94.04 \approx \varphi_p\left(\frac{a}{2N}\right),$$
(53)

for $(t, u, v) \in [0, 10]_{\mathbb{N}_0} \times [0, 500] \times [0, 65000]$. Consider

$$L = \frac{1.56 + 25.78}{2 \times 25.78} + \frac{1}{2} \times \frac{2.01 \times 1.01 \times 0.01}{2} + 12 \times 0.01$$

\$\approx 0.65 < 1. (54)

Thus, the conditions of Theorem 11 are satisfied. Therefore, the FBVP (49) has at least three positive solutions satisfying

$$\begin{aligned} x_{1}(t) &= \Delta_{0}^{0.05} y_{1}(t), \\ x_{2}(t) &= \Delta_{0}^{0.05} y_{2}(t), \\ x_{3}(t) &= \Delta_{0}^{0.05} y_{3}(t), \\ \max_{t \in [0,11]_{N_{0}}} |\Delta y_{i}(t)| &\leq 5000, \quad \text{for } i = 1, 2, 3, \end{aligned}$$

$$1800 < \min_{t \in [6,12]_{N_6}} |y_1(t)|, \qquad (55)$$
$$\max_{t \in [0,12]_{N_0}} |y_3(t)| < 500,$$
$$500 < \max_{t \in [0,12]_{N_0}} |y_2(t)|,$$
with
$$\min_{t \in [6,12]_{N_6}} |y_2(t)| < 1800.$$
