# GENERALIZED STRONGLY SET-VALUED NONLINEAR COMPLEMENTARITY PROBLEMS

ABSTRACT. In this paper, we introduce a new class of generalized strongly set-valued nonlinear complementarity problems and construct new iterative algorithms. We show the existence of solutions for this kind of nonlinear complementarity problems and the convergence of iterative sequences generated by the algorithm. Our results extend some recent results in this field.

Keywords and phrases. Complementarity problem, strongly monotone and Lipschitz continuous mappings, strongly monotone and *H*-Lipschitz continuous set-valued mappings, algorithm.

**1. Introduction.** The complementarity theory, which was introduced by Lemke [11], Cottle, and Dantzig [6] in the early 1960s and later developed by others, plays an important and fundamental role in the study of a wide class of problems arising in mechanics, physics, control and optimization, economics and transportation equilibrium, contact problems in elasticity, fluid flow through porous media, and many other branches of mathematical and engineering sciences [1, 2, 3, 4, 5, 7, 8, 9, 10, 13, 14, 15]. In particular, the set-valued quasi-(implicit)complementarity problems, considered and studied by Chang and Huang [2, 3], are important among the generalizations of the complementarity problems. In [14], Noor introduced and studied some new classes of nonlinear complementarity problems for single-valued mappings in  $\mathbb{R}^n$  and, in [4], Chang and Huang introduced and studied some new nonlinear complementarity problems, considered by Chang [1], Cottle et al. [7], Isac [9], and Noor [13, 14], as special cases.

In this paper, we introduce and study a new class of generalized strongly set-valued nonlinear complementarity problems and construct new iterative algorithms. We also discuss the existence of solutions for this kind of nonlinear complementarity problems and the convergence of iterative sequences generated by the algorithm. Our results improve and develop some results in [4, 13, 14].

**2. Preliminaries.** Let  $\mathbb{R}^n$  be the Euclidean space endowed with norm  $\|\cdot\|$  and inner product  $(\cdot, \cdot)$ , respectively. In the sequel, we use the following notations:

$$2^{\mathbb{R}^n} = \{A : A \subset \mathbb{R}^n \text{ and } A \text{ is nonempty}\},\tag{2.1}$$

$$CB(\mathbb{R}^n) = \{A : A \subset \mathbb{R}^n \text{ and } A \text{ is nonempty, bounded, and closed}\},$$

$$|x| = (|x_1|, |x_2|, \dots, |x_n|)$$
 for all  $x \in \mathbb{R}^n$ . (2.3)

Let *F*, *G*,  $Q : \mathbb{R}^n \to 2^{\mathbb{R}^n}$  be three set-valued mappings and *f*,  $g : \mathbb{R}^n \to \mathbb{R}^n$  be two single-valued mappings. Now, we consider the following problem.

Find  $u \in \mathbb{R}^n$ ,  $x \in F(u)$ ,  $y \in G(u)$ , and  $z \in Q(y)$  such that

$$u \ge 0, \qquad f(x) + g(z) \ge 0, \qquad (u, f(x) + g(x)) = 0.$$
 (2.4)

This problem is called the generalized strongly set-valued nonlinear complementarity problem.

If *Q* is the identity mapping on  $\mathbb{R}^n$ , then problem (2.4) is equivalent to the following. Find  $u \in \mathbb{R}^n$ ,  $x \in F(u)$  and  $y \in G(u)$  such that

$$u \ge 0, \qquad f(x) + g(y) \ge 0, \qquad (u, f(x) + g(y)) = 0.$$
 (2.5)

This problem is called the generalized set-valued nonlinear complementarity problem.

If *F* is the identity mapping on  $\mathbb{R}^n$ , then problem (2.5) is equivalent to the following. Find  $u \in \mathbb{R}^n$  and  $\gamma \in G(u)$  such that

$$u \ge 0, \qquad f(u) + g(y) \ge 0, \qquad (u, f(u) + g(y)) = 0,$$
 (2.6)

which was considered by Chang and Huang in [4].

If F = G is the identity mapping on  $\mathbb{R}^n$ , then problem (2.5) is equivalent to the following.

Find  $u \in \mathbb{R}^n$  such that

$$u \ge 0, \qquad f(u) + g(u) \ge 0, \qquad (u, f(u) + g(u)) = 0,$$
 (2.7)

which was considered by Noor [14].

If F = G is the identity mapping on  $\mathbb{R}^n$  and  $f \equiv 0$ , then problem (2.5) is equivalent to the following.

Find  $u \in \mathbb{R}^n$  such that

$$u \ge 0, \qquad g(u) \ge 0, \qquad (u, g(u)) = 0,$$
 (2.8)

which was considered by Karamardian [10], Fang [8], and Noor [13].

Obviously, problem (2.4) can be written as follows:

Find  $u \in \mathbb{R}^n$ ,  $x \in F(u)$ ,  $y \in G(u)$  and  $z \in Q(y)$  such that

$$u \ge 0, \qquad v = f(x) + g(z) \ge 0, \qquad (u, v) = 0.$$
 (2.9)

We now consider the following equalities:

$$u = \frac{1}{2} (|w| + w), \qquad v = (\lambda \rho)^{-1} (|w| - w), \tag{2.10}$$

where  $\lambda$ ,  $\rho > 0$  are constants. Clearly,  $u \ge 0$  and  $v \ge 0$ . From (2.5) and (2.9), it follows that problem (2.9) is equivalent to the following.

Find  $w \in \mathbb{R}^n$ ,  $x \in F(1/2(|w|+w))$ ,  $y \in G(1/2(|w|+w))$ , and  $z \in Q(y)$  such that

$$w = \frac{1}{2} (|w| + w) - \frac{1}{2} \lambda \rho (f(x) + g(z)), \qquad (2.11)$$

where  $\lambda$ ,  $\rho > 0$  are constants.

**3. Algorithms.** Based on the formulations in Section 2, we now construct the new algorithms for the generalized strongly set-valued nonlinear complementarity problem (2.4).

Let *F*, *G*, *Q* :  $\mathbb{R}^n \to CB(\mathbb{R}^n)$  be three set-valued mappings and let *f*, *g* :  $\mathbb{R}^n \to \mathbb{R}^n$  be two single-valued mappings. For any  $w_o \in \mathbb{R}^n$ , let

$$x_0 \in F\left(\frac{1}{2}(|w_0| + w_0)\right), \qquad y_0 \in G\left(\frac{1}{2}(|w_0| + w_0)\right), \qquad z_0 \in Q(y_0)$$
(3.1)

and

$$w_1 = \frac{1}{2}(1-\lambda)(|w_0|+w_0) + \frac{1}{2}\lambda(|w_0|+w_0-\rho(f(x_0)+g(z_0))),$$
(3.2)

where  $\lambda$ ,  $\rho > 0$  are constants.

Since  $x_0 \in F(1/2(|w_0|+w_0))$ ,  $y_0 \in G(1/2(|w_0|+w_0))$  and  $z_0 \in Q(y_0)$ , by Nadler [12], there exist  $x_1 \in F(1/2(|w_1|+w_1))$ ,  $y_1 \in G(1/2(|w_1|+w_1))$  and  $z_1 \in Q(y_1)$  such that

$$\|x_0 - x_1\| \le (1+1)H\Big(F\Big(\frac{1}{2}\big(|w_0| + w_0\big)\Big), F\Big(\frac{1}{2}\big(|w_1| + w_1\big)\Big)\Big), \tag{3.3}$$

$$\|y_0 - y_1\| \le (1+1)H\Big(G\Big(\frac{1}{2}\big(|w_0| + w_0\big)\Big), G\Big(\frac{1}{2}\big(|w_1| + w_1\big)\Big)\Big), \tag{3.4}$$

$$\|z_1 - z_0\| \le (1+1)H(Q(y_1), Q(y_0)),$$
(3.5)

where  $H(\cdot, \cdot)$  denotes the Hausdorff metric on  $CB(\mathbb{R}^n)$ .

Thus, by induction, we can obtain the following algorithm:

**ALGORITHM 3.1.** Let F, G,  $Q : \mathbb{R}^n \to CB(\mathbb{R}^n)$  be three set-valued mappings and let f,  $g : \mathbb{R}^n \to \mathbb{R}^n$  be two single-valued mappings. For any  $w_0 \in \mathbb{R}^n$ , we can construct sequences  $\{w_n\}, \{x_n\}, \{y_n\}$ , and  $\{z_n\}$  in  $\mathbb{R}^n$  as follows:

$$\begin{aligned} x_{n} &\in F\left(\frac{1}{2}(|w_{n}|+w_{n})\right), \qquad y_{n} \in G\left(\frac{1}{2}(|w_{n}|+w_{n})\right), \qquad z_{n} \in Q(y_{n}), \\ \|x_{n}-x_{n+1}\| &\leq \left(1+\frac{1}{n+1}\right)H\left(F\left(\frac{1}{2}(|w_{n}|+w_{n})\right), F\left(\frac{1}{2}(|w_{n+1}|+w_{n+1})\right)\right), \\ \|y_{n}-y_{n+1}\| &\leq \left(1+\frac{1}{n+1}\right)H\left(G\left(\frac{1}{2}(|w_{n}|+w_{n})\right), G\left(\frac{1}{2}(|w_{n+1}|+w_{n+1})\right)\right), \\ \|z_{n}-z_{n+1}\| &\leq \left(1+\frac{1}{n+1}\right)H\left(Q(y_{n}), Q(y_{n+1})\right), \\ w_{n+1} &= \frac{1}{2}(1-\lambda)(|w_{n}|+w_{n}) + \frac{1}{2}\lambda\left(|w_{n}|+w_{n}-\rho(f(x_{n})+g(z_{n}))\right) \end{aligned}$$
(3.6)

for n = 0, 1, 2, ..., where  $\lambda$ ,  $\rho > 0$  are constants.

From Algorithm 3.1, we can obtain the following algorithms.

**ALGORITHM 3.2.** Let  $F, G : \mathbb{R}^n \to CB(\mathbb{R}^n)$  be two set-valued mappings and let  $f, g : \mathbb{R}^n \to \mathbb{R}^n$  be two single-valued mappings. For any  $w_0 \in \mathbb{R}^n$ , we can construct sequences

 $\{w_n\}, \{x_n\}$ , and  $\{y_n\}$  in  $\mathbb{R}^n$  as follows:

$$\begin{aligned} x_{n} &\in F\left(\frac{1}{2}(|w_{n}|+w_{n})\right), \qquad y_{n} \in G\left(\frac{1}{2}(|w_{n}|+w_{n})\right), \\ \|x_{n}-x_{n+1}\| &\leq \left(1+\frac{1}{n+1}\right)H\left(F\left(\frac{1}{2}(|w_{n}|+w_{n})\right), F\left(\frac{1}{2}(|w_{n+1}|+w_{n+1})\right)\right), \\ \|y_{n}-y_{n+1}\| &\leq \left(1+\frac{1}{n+1}\right)H\left(G\left(\frac{1}{2}(|w_{n}|+w_{n})\right), G\left(\frac{1}{2}(|w_{n+1}|+w_{n+1})\right)\right), \\ w_{n+1} &= \frac{1}{2}(1-\lambda)\left(|w_{n}|+w_{n}\right) + \frac{1}{2}\lambda\left(|w_{n}|+w_{n}-\rho\left(f(x_{n})+g(z_{n})\right)\right) \end{aligned}$$
(3.7)

for n = 0, 1, 2, ..., where  $\lambda, \rho > 0$  are constants.

**ALGORITHM 3.3** [4]. Let  $G : \mathbb{R}^n \to CB(\mathbb{R}^n)$  be a set-valued mapping and let  $f, g : \mathbb{R}^n \to \mathbb{R}^n$  be two single-valued mappings. For any  $w_0 \in \mathbb{R}^n$ , we can construct sequences  $\{w_n\}$  and  $\{y_n\}$  in  $\mathbb{R}^n$  as follows:

$$y_n \in G\left(\frac{1}{2}(|w_n| + w_n)\right),\tag{3.8}$$

$$||y_{n} - y_{n+1}|| \le \left(1 + \frac{1}{n+1}\right) H\left(G\left(\frac{1}{2}(|w_{n}| + w_{n})\right), G\left(\frac{1}{2}(|w_{n+1}| + w_{n+1})\right)\right),$$
(3.9)

$$w_{n+1} = \frac{1}{2}(1-\lambda)\left(|w_n| + w_n\right) + \frac{1}{2}\lambda\left(|w_n| + w_n - \rho\left(f\left(\frac{1}{2}(|w_n| + w_n)\right) + g(y_n)\right)\right)$$
(3.10)

for n = 0, 1, 2, ..., where  $\lambda$ ,  $\rho > 0$  are constants.

**ALGORITHM 3.4.** [14] Let  $f, g : \mathbb{R}^n \to \mathbb{R}^n$  be two single-valued mappings. For any  $w_0 \in \mathbb{R}^n$ , we can construct sequences  $\{w_n\}$  and  $\{y_n\}$  in  $\mathbb{R}^n$  as follows.

$$y_n = \frac{1}{2} (|w_n| + w_n), \tag{3.11}$$

$$w_{n+1} = \frac{1}{2}(1-\lambda)(|w_n|+w_n) + \frac{1}{2}\lambda(|w_n|+w_n-\rho(f(\frac{1}{2}(|w_n|+w_n))+g(y_n)))$$
(3.12)

for n = 0, 1, 2, ..., where  $\lambda$ ,  $\rho > 0$  are constants.

**ALGORITHM 3.5.** [15] Let  $g : \mathbb{R}^n \to \mathbb{R}^n$  be a single-valued mapping. For any  $w_0 \in \mathbb{R}^n$ , we can construct sequences  $\{w_n\}$  and  $\{y_n\}$  in  $\mathbb{R}^n$  as follows.

$$y_n = \frac{1}{2} (|w_n| + w_n), \tag{3.13}$$

$$w_{n+1} = \frac{1}{2}(1-\lambda)(|w_n|+w_n) + \frac{1}{2}\lambda(|w_n|+w_n-\rho(g(\gamma_n)))$$
(3.14)

for n = 0, 1, 2, ..., where  $\lambda$ ,  $\rho > 0$  are constants.

**4. Existence and convergence.** In this section, we show the existence of solutions for the generalized strongly set-valued nonlinear complementarity problem (2.4) and the convergence of the iterative sequences constructed by Algorithm 3.1. We first give some definitions.

## **DEFINITIONS 4.1.**

(1) A mapping  $f : \mathbb{R}^n \to \mathbb{R}^n$  is said to be *strongly monotone* if there exists a constant  $\alpha > 0$  such that

$$(f(u) - f(v), u - v) \ge \alpha ||u - v||^2$$
  
(4.1)

for all  $u, v \in \mathbb{R}^n$ .

(2) A mapping  $f : \mathbb{R}^n \to \mathbb{R}^n$  is said to be *Lipschitz continuous* if there exists a constant  $\beta > 0$  such that

$$||f(u) - f(v)|| \le \beta ||u - v||$$
 (4.2)

for all  $u, v \in \mathbb{R}^n$ . The number  $\beta$  in (2) is called *Lipschitz constant*.

It is easy to see that  $\alpha \leq \beta$ .

## **DEFINITIONS 4.2.**

(1) A set-valued mapping  $F : \mathbb{R}^n \to CB(\mathbb{R}^n)$  is said to be *strongly monotone with respect to the mapping*  $f : \mathbb{R}^n \to \mathbb{R}^n$  if there exists a constant  $\alpha > 0$  such that

$$(f(x) - f(y), u - v) \ge \alpha ||u - v||^2$$
(4.3)

for all  $u, v \in \mathbb{R}^n$ ,  $x \in F(u)$  and  $y \in F(v)$ .

(2) A set-valued mapping  $F : \mathbb{R}^n \to CB(\mathbb{R}^n)$  is said to be *H*-*Lipschitz continuous* if there exists a constant  $\beta > 0$  such that

$$H(F(u),F(v)) \le \beta \|u-v\| \tag{4.4}$$

for all  $u, v \in \mathbb{R}^n$ . The number  $\beta$  in (2) is called the *H*-*Lipschitz constant*.

Now, we give our main theorems in this paper.

**THEOREM 4.1.** Suppose that  $f, g : \mathbb{R}^n \to \mathbb{R}^n$  are Lipschitz continuous with Lipschitz constants  $\delta$  and  $\xi$ , respectively, and  $F, G, Q : \mathbb{R}^n \to CB(\mathbb{R}^n)$  are *H*-Lipschitz continuous with *H*-Lipschitz constants  $\beta, \eta, \nu$ , respectively, and *F* is strongly monotone with respect to *f* with strongly monotone constant  $\alpha$ . If

$$0 < \rho < \frac{4(\alpha - \xi \nu \eta)}{(\delta \beta)^2 - (\xi \nu \eta)^2}, \qquad \rho \xi \nu \eta < 2, \qquad \xi \nu \eta < \min\{\alpha, \delta \beta\}, \tag{4.5}$$

then there exist  $u, x, y, z \in \mathbb{R}^n$  which solve problem (2.4). Furthermore, it follows that

$$\frac{1}{2}(|w_n|+w_n) \to u, \qquad x_n \to x, \qquad y_n \to y, \qquad z_n \to z \quad as \ n \to \infty,$$
(4.6)

where  $\{w_n\}, \{x_n\}, \{y_n\}, and \{z_n\}$  in  $\mathbb{R}^n$  are the sequences generated by Algorithm 3.1.

**PROOF.** By Algorithm 3.1, we have

$$\begin{aligned} \|w_{n+1} - w_n\| \\ &= \left\| \frac{1}{2} (1 - \lambda) \left( |w_n| + w_n \right) + \frac{1}{2} \lambda \left( |w_n| + w_n - \rho \left( f(x_n) + g(z_n) \right) \right) \\ &- \frac{1}{2} (1 - \lambda) \left( |w_{n-1}| + w_{n-1} \right) - \frac{1}{2} \lambda \left( |w_{n-1}| + w_{n-1} - \rho \left( f(x_{n-1}) + g(z_{n-1}) \right) \right) \right\| \\ &\leq (1 - \lambda) \|w_n - w_{n-1}\| + \frac{1}{2} \lambda \rho \|g(z_n) - g(z_{n-1})\| \\ &+ \lambda \left\| \frac{1}{2} (|w_n| + w_n) - \frac{1}{2} \left( |w_{n-1}| + w_{n-1} \right) - \frac{1}{2} \rho \left( f(x_n) - f(x_{n-1}) \right) \right\|. \end{aligned}$$

$$(4.7)$$

Since *F*, *G*, and *Q* are *H*-Lipschitz continuous and *f* and *g* are Lipschitz continuous, from (3.6), it follows that

$$\begin{split} ||f(x_{n}) - f(x_{n-1})|| &\leq \delta ||x_{n} - x_{n-1}|| \\ &\leq \delta \left(1 + \frac{1}{n}\right) H \left(F\left(\frac{1}{2}(|w_{n}| + w_{n})\right), F\left(\frac{1}{2}(|w_{n-1}| + w_{n-1})\right)\right) \\ &\leq \delta \left(1 + \frac{1}{n}\right) \beta \left\|\frac{|w_{n}| + w_{n}}{2} - \frac{|w_{n-1}| + w_{n-1}}{2}\right\| \\ &\leq \delta \left(1 + \frac{1}{n}\right) \beta ||w_{n} - w_{n-1}|| \end{split}$$

$$(4.8)$$

and

$$\begin{aligned} ||g(z_{n}) - g(z_{n-1})|| \\ &\leq \xi ||z_{n} - z_{n-1}|| \leq \xi \left(1 + \frac{1}{n}\right) H(Q(y_{n}), Q(y_{n-1})) \\ &\leq \xi v \left(1 + \frac{1}{n}\right) ||y_{n} - y_{n-1}|| \\ &\leq \xi v \left(1 + \frac{1}{n}\right)^{2} H\left(G\left(\left(\frac{1}{2}(|w_{n}| + w_{n})\right), G\left(\frac{1}{2}(|w_{n-1}| + w_{n-1})\right)\right)\right) \\ &\leq \xi v \left(1 + \frac{1}{n}\right)^{2} \eta ||w_{n} - w_{n-1}||. \end{aligned}$$

$$(4.9)$$

Further, from the strong monotonicity of F with respect to f and (4.8), we have

$$\left\| \frac{1}{2} (|w_{n}| + w_{n}) - \frac{1}{2} (|w_{n-1}| + w_{n-1}) - \frac{1}{2} \rho(f(x_{n}) - f(x_{n-1})) \right\|^{2} \\ \leq \left( 1 - \alpha \rho + \frac{1}{4} \rho^{2} \delta^{2} \left( 1 + \frac{1}{n} \right)^{2} \beta^{2} \right) ||w_{n} - w_{n-1}||^{2}.$$

$$(4.10)$$

Thus, it follows, from (4.7), (4.8), (4.9), and (4.10), that

$$\begin{aligned} ||w_{n+1} - w_n|| \\ \leq \left(1 - \lambda + \frac{1}{2}\lambda\rho\xi\eta\left(1 + \frac{1}{n}\right) + \lambda\sqrt{1 - \alpha\rho + \frac{1}{4}\rho^2\delta^2\beta^2\left(1 + \frac{1}{n}\right)^2}\right)||w_n - w_{n-1}|| \\ = \theta_n||w_n - w_{n-1}||, \end{aligned}$$
(4.11)

where

$$\theta_n = 1 - \lambda + \frac{1}{2}\lambda\rho\xi\nu\eta\left(1 + \frac{1}{n}\right)^2 + \lambda\sqrt{1 - \alpha\rho + \frac{1}{4}\rho^2\delta^2\beta^2\left(1 + \frac{1}{n}\right)^2}.$$
(4.12)

Letting

$$\theta = 1 - \lambda + \frac{1}{2}\lambda\rho\xi\nu\eta + \lambda\sqrt{1 - \alpha\rho + \frac{1}{4}\rho^2\delta^2\beta^2},$$
(4.13)

 $\theta_n \to \theta$  as  $n \to \infty$ . In view of (4.5), we know that  $0 < \theta < 1$  and so  $\theta_n < 1$  for n sufficiently large. It follows from (4.11) that  $\{w_n\}$  is a Cauchy sequence in  $\mathbb{R}^n$  and so

we can suppose that  $w_n \to w$  as  $n \to \infty$ . (4.8) and (4.9) imply that  $\{x_n\}, \{y_n\}$ , and  $\{z_n\}$  are also Cauchy sequences in  $\mathbb{R}^n$ . Let  $x_n \to x$ ,  $y_n \to y$ , and  $z_n \to z$  as  $n \to \infty$ . Letting  $u = \frac{1}{2}(|w| + w)$ , we get

$$\frac{1}{2}(|w_n|+w_n) \to u, \quad x_n \to x, \quad y_n \to y, \quad z_n \to z \text{ as } n \to \infty.$$
(4.14)

Now, we prove that  $x \in F(u)$ ,  $y \in G(u)$ , and  $z \in Q(y)$ . In fact, we have

$$d(x,F(u)) = \inf\{ ||x-z|| : z \in F(u) \}$$
  

$$\leq ||x-x_n|| + d(x_n,F(u))$$
  

$$\leq ||x-x_n|| + H\left(F\left(\frac{1}{2}(|w_n|+w_n)\right),F(u)\right)$$
  

$$\leq ||x-x_n|| + \beta \left\|\frac{1}{2}(|w_n|+w_n) - u\right\|,$$
(4.15)

and hence d(x, F(u)) = 0. This implies that  $x \in F(u)$ . Similarly, we have  $y \in G(u)$  and  $z \in Q(y)$ . This completes the proof.

From Theorem 4.1, we get the following theorem.

**THEOREM 4.2.** Suppose that  $f, g : \mathbb{R}^n \to \mathbb{R}^n$  are Lipschitz continuous with Lipschitz constants  $\delta$  and  $\xi$ , respectively, and  $F, G : \mathbb{R}^n \to CB(\mathbb{R}^n)$  are *H*-Lipschitz continuous with *H*-Lipschitz constants  $\beta$  and  $\eta$ , respectively, and *F* is strongly monotone with respect to *f* with strongly monotone constant  $\alpha$ . If

$$0 < \rho < \frac{4(\alpha - \xi\eta)}{(\delta\beta)^2 - (\xi\eta)^2}, \qquad \rho\xi\eta < 2, \qquad \xi\eta < \min\{\alpha, \delta\beta\}, \tag{4.16}$$

then there exist  $u, x, y \in \mathbb{R}^n$  which solve problem (2.5). Furthermore, it follows that

$$\frac{1}{2}(|w_n|+w_n) \to u, \qquad x_n \to x, \qquad y_n \to y \quad as \ n \to \infty, \tag{4.17}$$

where  $\{w_n\}$ ,  $\{x_n\}$ , and  $\{y_n\}$  in  $\mathbb{R}^n$  are the sequences generated by Algorithm 3.2.

**THEOREM 4.3** [4]. Let f, g, and G be the same as in Theorem 4.2. Further, suppose that f is strongly monotone with strongly monotone constant  $\alpha$ . If

$$0 < \rho < \frac{4(\alpha - \xi\eta)}{\delta^2 - (\xi\eta)^2}, \qquad \rho \xi\eta < 2, \qquad \xi\eta < \alpha, \tag{4.18}$$

then there exist  $u, y \in \mathbb{R}^n$  which solve problem (2.6), and

$$\frac{1}{2}(|w_n| + w_n) \longrightarrow u, \qquad y_n \longrightarrow y, \quad as \ n \longrightarrow \infty, \tag{4.19}$$

where  $\{w_n\}$  and  $\{y_n\}$  are two sequences generated by Algorithm 3.3.

**THEOREM 4.4** [14]. Let f and g be the same as in Theorem 4.3. If

$$0 < \rho < \frac{4(\alpha - \xi)}{\delta^2 - \xi^2}, \qquad \rho \xi < 2, \qquad \xi < \alpha, \tag{4.20}$$

then there exists  $u \in \mathbb{R}^n$  which is a solution of problem (2.7), and  $\frac{1}{2}(|w_n| + w_n) \rightarrow u$  as  $n \rightarrow \infty$ , where  $\{w_n\}$  is the sequence generated by Algorithm 3.4.

**THEOREM 4.5** [15]. Suppose that  $g : \mathbb{R}^n \to \mathbb{R}^n$  is strongly monotone and Lipschitz continuous with strongly monotone constant  $\alpha$  and Lipschitz constant  $\delta$ . If  $0 < \rho < 4\alpha/\delta^2$ , then there exists  $u \in \mathbb{R}^n$  which is a solution of problem (2.8), and  $\frac{1}{2}(|w_n|+w_n) \to u$  as  $n \to \infty$ , where  $\{w_n\}$  is the sequence generated by Algorithm 3.5.
