

A TYCHONOFF THEOREM IN INTUITIONISTIC FUZZY TOPOLOGICAL SPACES

The purpose of this paper is to prove a Tychonoff theorem in the so-called “intuitionistic fuzzy topological spaces.” After giving the fundamental definitions, such as the definitions of intuitionistic fuzzy set, intuitionistic fuzzy topology, intuitionistic fuzzy topological space, fuzzy continuity, fuzzy compactness, and fuzzy dcompactness, we obtain several preservation properties and some characterizations concerning fuzzy compactness. Lastly we give a Tychonoff-like theorem.

1. Introduction. After the introduction of the concept of fuzzy sets by Zadeh [8] several researches were conducted on the generalizations of the notion of fuzzy set. The idea of intuitionistic fuzzy set (IFS) was first published by Atanassov [1] and many works by the same author and his colleagues appeared in the literature [1, 3, 4].

Later, this concept was generalized to “intuitionistic L -fuzzy sets” by Atanassov and Stoeva [4].

2. Preliminaries. First we will present the fundamental definitions obtained by Atanassov.

DEFINITION 2.1 [1]. Let X be a nonempty fixed set. An IFS A is an object having the form

$$A = \{ \langle x, \mu_A(x), \gamma_A(x) \rangle : x \in X \}, \quad (2.1)$$

where the functions $\mu_A : X \rightarrow I$ and $\gamma_A : X \rightarrow I$ denote the degree of membership (namely, $\mu_A(x)$) and the degree of nonmembership (namely, $\gamma_A(x)$) of each element $x \in X$ to the set A , respectively, and $0 \leq \mu_A(x) + \gamma_A(x) \leq 1$ for each $x \in X$.

REMARK 2.2. An IFS $A = \{ \langle x, \mu_A(x), \gamma_A(x) \rangle : x \in X \}$ in X can be identified to an ordered pair $\langle \mu_A, \gamma_A \rangle$ in $I^X \times I^X$ or to an element in $(I \times I)^X$.

REMARK 2.3. For the sake of simplicity, we will use the symbol $A = \langle x, \mu_A, \gamma_A \rangle$ for the IFS $A = \{ \langle x, \mu_A(x), \gamma_A(x) \rangle : x \in X \}$.

EXAMPLE 2.4. Every fuzzy set A on a nonempty set X is obviously an IFS having the form $A = \{ \langle x, \mu_A(x), 1 - \mu_A(x) \rangle : x \in X \}$ [1].

One can define several relations and operations between IFSs as follows.

DEFINITION 2.5 [2]. Let X be a nonempty set, and let the IFSs A and B be in the form $A = \{\langle x, \mu_A(x), \gamma_A(x) \rangle : x \in X\}$, $B = \{\langle x, \mu_B(x), \gamma_B(x) \rangle : x \in X\}$. Then

- (a) $A \subseteq_{\square} B$ if and only if for all $x \in X$ [$\mu_A(x) \leq \mu_B(x)$];
- (b) $A \subseteq_{\diamond} B$ if and only if for all $x \in X$ [$\gamma_A(x) \geq \gamma_B(x)$];
- (c) $A \subseteq B$ if and only if $A \subseteq_{\square} B$ and $A \subseteq_{\diamond} B$;
- (d) $A = B$ if and only if $A \subseteq B$ and $B \subseteq A$;
- (e) $A[B$ if and only if for all $x \in X$ [$\pi_A(x) \leq \pi_B(x)$], where $\pi_A : X \rightarrow I$, $\pi_A(x) = 1 - \mu_A(x) - \gamma_A(x)$;
- (f) $\bar{A} = \{\langle x, \gamma_A(x), \mu_A(x) \rangle : x \in X\}$;
- (g) $A \cap B = \{\langle x, \mu_A(x) \wedge \mu_B(x), \gamma_A(x) \vee \gamma_B(x) \rangle : x \in X\}$;
- (h) $A \cup B = \{\langle x, \mu_A(x) \vee \mu_B(x), \gamma_A(x) \wedge \gamma_B(x) \rangle : x \in X\}$;
- (i) $\square A = \{\langle x, \mu_A(x), 1 - \mu_A(x) \rangle : x \in X\}$;
- (j) $\diamond A = \{\langle x, 1 - \gamma_A(x), \gamma_A(x) \rangle : x \in X\}$.

We can easily generalize the operations of intersection and union in Definition 2.5 to arbitrary family of IFSs as follows.

DEFINITION 2.6. Let $\{A_i : i \in J\}$ be an arbitrary family of IFSs in X . Then

- (a) $\cap A_i = \{\langle x, \wedge \mu_{A_i}(x), \vee \gamma_i(x) \rangle : x \in X\}$;
- (b) $\cup A_i = \{\langle x, \vee \mu_{A_i}(x), \wedge \gamma_{A_i}(x) \rangle : x \in X\}$.

DEFINITION 2.7. The ordinary complement of $A = \langle x, \mu_A, \gamma_A \rangle$ is defined by

$$A^C = \langle x, 1 - \gamma_A, 1 - \mu_A \rangle. \quad (2.2)$$

DEFINITION 2.8. $0_{\sim} = \{\langle x, 0, 1 \rangle : x \in X\}$ and $1_{\sim} = \{\langle x, 1, 0 \rangle : x \in X\}$.

Now we will define the image and preimage of IFSs. Let X and Y be two nonempty sets and let $f : X \rightarrow Y$ be a function. If $B = \{\langle y, \mu_B(y), \gamma_B(y) \rangle : y \in Y\}$ is an IFS in Y , then the preimage of B under f , denoted by $f^{-1}(B)$, is the IFS in X defined by

$$f^{-1}(B) = \{\langle x, f^{-1}(\mu_B)(x), f^{-1}(\gamma_B)(x) \rangle : x \in X\}. \quad (2.3)$$

Similarly, if $A = \{\langle x, \lambda_A(x), \nu_A(x) \rangle : x \in X\}$ is an IFS in X , then the image of A under f , denoted by $f(A)$, is the IFS in Y defined by $f(A) = \{\langle y, f(\lambda_A)(y), f(\nu_A)(y) \rangle : y \in Y\}$.

Now we generalize the concept of fuzzy topological space, first initiated by Chang [6], to the case of IFSs.

This construction, in some sense, has a close resemblance to that of Brown [5], the so-called “fuzzy ditopological space.”

DEFINITION 2.9 [7]. An intuitionistic fuzzy topology (IFT) on a nonempty set X is a family τ of IFSs in X satisfying the following axioms:

- (T₁) $0_{\sim}, 1_{\sim} \in \tau$,
- (T₂) $G_1 \cap G_2 \in \tau$ for any $G_1, G_2 \in \tau$,
- (T₃) $\cup G_i \in \tau$, for any arbitrary family $\{G_i : i \in \tau\} \subseteq \tau$.

In this case the pair (X, τ) is called an intuitionistic fuzzy topological space (IFTS) and any IFS in τ is known as an intuitionistic fuzzy open set (IFOS) in X .

EXAMPLE 2.10. Any fuzzy topological space (X, τ_0) in the sense of Chang is obviously an IFTS whenever we identify a fuzzy set A in X whose membership function is μ_A with its counterpart

$$\{\langle x, \mu_A(x), 1 - \mu_A(x) \rangle : x \in X\} \quad (2.4)$$

as in [Example 2.4](#).

EXAMPLE 2.11. Let (X, τ_0) be a fuzzy topological space in Chang's sense such that τ_0 is not indiscrete. Suppose now that $\tau_0 = \{0_-, 1_-\} \cup \{\nu_i : i \in J\}$. Then we can construct two IFTs on X as follows:

- (1) $\tau^1 = \{0_-, 1_-\} \cup \{\langle x, \nu_i, 0 \rangle : i \in J\}$,
- (2) $\tau^2 = \{0_-, 1_-\} \cup \{\langle x, 0, 1 - \nu_i \rangle : i \in J\}$.

EXAMPLE 2.12. Let (X, τ) be an IFTS on X . Then, if $\tau = \{G_i : i \in J\}$, where $G_i = \langle x, \mu_{G_i}, \gamma_{G_i} \rangle$, $i \in J$, then we can also construct several IFTSs on X in the following way:

- (1) $\tau_{0,1} = \{\Box G_i : i \in J\}$,
- (2) $\tau_{0,2} = \{\Diamond G_i : i \in J\}$,
- (3) $\tau^C = \{G_i^C : i \in J\}$ (the conjugate fuzzy topology of τ).

EXAMPLE 2.13. Let (X, τ) be an IFTS.

- (a) $\tau_1 = \{\mu_G : G \in \tau\}$ is a fuzzy topological space on X in Chang's sense.
- (b) $\tau_2^* = \{\gamma_G : G \in \tau\}$ is the family of all fuzzy closed sets of the fuzzy topological space $\tau_2 = \{1 - \gamma_G : G \in \tau\}$ on X in Chang's sense.
- (c) Since $0 \leq \mu_A(x) + \gamma_A(x) \leq 1$ for each $x \in X$ and each $G \in \tau$, we obtain $\mu_G \leq 1 - \gamma_G$.
- (d) Using (a) and (b) we may conclude that (X, τ_1, τ_2) is a bifuzzy topological space.

DEFINITION 2.14. An IFTS in the sense of Lowen is a pair $\langle X, \tau \rangle$ where $\langle X, \tau \rangle$ is an IFTS and each IFS in the form $C_{\alpha, \beta} = \{\langle x, \alpha, \beta \rangle : x \in X\}$, where $\alpha, \beta \in I$ are arbitrary ($\alpha + \beta \leq 1$), belongs to τ .

Notice that any fuzzy topological space (X, τ) in the sense of Lowen is obviously an IFTS in the sense of Lowen.

DEFINITION 2.15. The complement A of an IFOS A in an IFTS (X, τ) is called an intuitionistic fuzzy closed set (IFCS) in X .

DEFINITION 2.16. Let (X, τ) be an IFTS on X .

- (a) A subfamily $\beta \subseteq \tau$ is called a base for (X, τ) , if each member of τ can be written as a union of elements in β .
- (b) A subfamily $S \subseteq \tau$ is called a subbase for (X, τ) , if the family of all finite intersections of S forms a base for (X, τ) . In this case it is said that (X, τ) is generated by S .

Now we define fuzzy closure and interior operators in an IFTS.

DEFINITION 2.17. Let (X, τ) be an IFTS and let $A = \{\langle x, \mu_A(x), \gamma_A(x) \rangle : x \in X\}$ be an IFS in X . Then the fuzzy interior and fuzzy closure of A is defined by

$$\begin{aligned} \text{cl}(A) &= \cap \{K : K \text{ is an IFCS in } X, A \subseteq K\}, \\ \text{int}(A) &= \cup \{G : G \text{ is an IFOS in } X, G \subseteq A\}. \end{aligned} \quad (2.5)$$

It can also be shown that $\text{cl}(A)$ is an IFCS and $\text{int}(A)$ is an IFOS in X , and A is an IFCS in X if and only if $\text{cl}(A) = A$, A is an IFOS in X if and only if $\text{int}(A) = A$. In addition, for any IFS A in (X, τ) ,

- (a) $\text{cl}(A^-) = \text{int}(A)^-$,
- (b) $\text{int}(A^-) = \text{cl}(A)^-$.

For further properties of fuzzy interior and closure operators you may consult [7].

PROPOSITION 2.18. Let (X, τ) be an IFTS. If $A = \langle x, \mu_A, \gamma_A \rangle$ is an IFS in X , then

$$\begin{aligned} \text{int}(A) &\subseteq \langle x, \text{int}_{\tau_1}(\mu_A), \text{cl}_{\tau_2}(\gamma_A) \rangle \subseteq A, \\ A &\subseteq \langle x, \text{cl}_{\tau_2}(\mu_A), \text{int}_{\tau_1}(\gamma_A) \rangle \subseteq \text{cl}(A), \end{aligned} \quad (2.6)$$

where τ_1 and τ_2 are the fuzzy topological spaces on X defined in [Example 2.13](#).

Now we present the basic definitions concerning fuzzy continuity.

DEFINITION 2.19. Let (X, τ) and (Y, ϕ) be two IFTSs and let $f : X \rightarrow Y$ be a function. Then f is said to be fuzzy continuous if and only if the preimage of each IFOS in ϕ is an IFOS in τ .

DEFINITION 2.20. Let (X, τ) and (Y, ϕ) be two IFTSs and let $f : X \rightarrow Y$ be a function. Then f is said to be fuzzy open if and only if the image of each IFS in τ is an IFS in ϕ .

EXAMPLE 2.21. Let (X, τ_0) , (X, ϕ_0) be two fuzzy topological spaces in the sense of Chang.

(a) If $f : X \rightarrow Y$ is fuzzy continuous in the usual sense, then in this case, f is fuzzy continuous in the sense of [Definition 2.19](#), too.

(b) If $f : X \rightarrow Y$ is fuzzy open in the usual sense, then f need not be fuzzy open in the sense of [Definition 2.20](#). (If, furthermore, $f : X \rightarrow Y$ were both one-to-one and onto, then f would also be fuzzy open in the sense of [Definition 2.20](#).)

EXAMPLE 2.22. Let (X, τ) be an IFTS in the sense of Lowen, (Y, ϕ) an IFTS, and $c_0 \in Y$. Then the constant function $c : X \rightarrow Y$, $c(x) = c_0$ is obviously fuzzy continuous.

EXAMPLE 2.23. Let (Y, ϕ) be an IFTS, X a nonempty set, and $f : X \rightarrow Y$ a function. In this case $\tau = \{f^{-1}(H) : H \in \phi\}$ is an IFT on X .

Indeed, τ is the coarsest IFT on X which makes the function $f : X \rightarrow Y$ fuzzy continuous. One may call the IFT τ on X the initial IFT with respect to f .

PROPOSITION 2.24. Let $f : (X, \tau) \rightarrow (Y, \phi)$ be a fuzzy continuous function. Then the functions (a) $f : (X, \tau_1) \rightarrow (Y, \phi_1)$, (b) $f : (X, \tau_2) \rightarrow (Y, \phi_2)$ are also fuzzy continuous,

where $\tau_1, \phi_1, \tau_2, \phi_2$ are the fuzzy topological spaces defined in [Example 2.13](#). (In other words, $\tau_1 = \{\mu_{G_i} : G_i \in \tau\}$, $\phi_1 = \{\lambda_{H_j} : H_j \in \phi\}$, $\tau_2 = \{1 - \gamma_{G_i} : G_i \in \tau\}$, $\phi_2 = \{1 - \gamma_{H_j} : H_j \in \phi\}$ if $\tau = \{G_i : i \in J\}$, $\phi = \{H_j : j \in K\}$, $G_i = \langle x, \mu_{G_i}, \gamma_{G_i} \rangle$ and $H_j = \langle x, \lambda_{H_j}, \gamma_{H_j} \rangle$.)

The proof of [Proposition 2.24](#) follows immediately from the definitions.

3. Intuitionistic fuzzy compactness. First we present the basic concepts.

DEFINITION 3.1 [7]. Let (X, τ) be an IFTS.

(a) If a family $\{\langle x, \mu_{G_i}, \gamma_{G_i} \rangle : i \in J\}$ of IFOs in X satisfies the condition $\cup \{\langle x, \mu_{G_i}, \gamma_{G_i} \rangle : i \in J\} = 1_{\sim}$, then it is called a fuzzy open cover of X . A finite subfamily of a fuzzy open cover $\{\langle x, \mu_{G_i}, \gamma_{G_i} \rangle : i \in J\}$ of X , which is also a fuzzy open cover of X , is called a finite subcover of $\{\langle x, \mu_{G_i}, \gamma_{G_i} \rangle : i \in J\}$.

(b) A family $\{\langle x, \mu_{K_i}, \gamma_{K_i} \rangle : i \in J\}$ of IFCs in X satisfies the finite intersection property (FIP) if and only if every finite subfamily $\{\langle x, \mu_{K_i}, \gamma_{K_i} \rangle : i = 1, 2, 3, \dots, n\}$ of the family satisfies the condition $\cap \langle x, \mu_{K_i}, \gamma_{K_i} \rangle \neq 0_{\sim}$.

(c) An IFTS (X, τ) is called fuzzy compact if and only if every fuzzy open cover of X has a finite subcover.

Now we will give two characterizations of fuzzy compactness.

PROPOSITION 3.2. *An IFTS (X, τ) is fuzzy compact if and only if for each family $\delta = \{G_i : i \in J\}$, where $G_i = \langle x, \mu_{G_i}, \gamma_{G_i} \rangle$ ($i \in J$) of IFOs in X with the properties $\vee \mu_{G_i} = 1$ and $\vee (1 - \gamma_{G_i}) = 1$, there exists a finite subfamily $\{G_i : i = 1, 2, \dots, n\}$ of δ such that $\vee_{i=1}^n \mu_{G_i} = 1$ and $\vee_{i=1}^n (1 - \gamma_{G_i}) = 1$.*

The proof of [Proposition 3.2](#) is obvious.

PROPOSITION 3.3. *An IFTS (X, τ) is fuzzy compact if and only if every family $\{\langle x, \mu_{K_i}, \gamma_{K_i} \rangle : i \in J\}$ of IFCs on X having the FIP has a nonempty intersection.*

For the proof of [Proposition 3.3](#) see [7]. Here we state that fuzzy compactness is preserved under a fuzzy continuous bijection.

PROPOSITION 3.4. *Let $(X, \tau), (Y, \phi)$ be IFTSs and $f : X \rightarrow Y$ a fuzzy continuous bijection. If (X, τ) is fuzzy compact, then so is (Y, ϕ) .*

For the proof of [Proposition 3.4](#) see [7].

DEFINITION 3.5 [7]. Let (X, τ) be an IFTS and A an IFS in X .

(a) If a family $\{\langle x, \mu_{G_i}, \gamma_{G_i} \rangle : i \in J\}$ of IFOs in X satisfies the condition $A \subseteq \cup \{\langle x, \mu_{G_i}, \gamma_{G_i} \rangle : i \in J\}$, then it is called a fuzzy open over of A . A finite subfamily of the fuzzy open cover $\{\langle x, \mu_{G_i}, \gamma_{G_i} \rangle : i \in J\}$ of A , which is also a fuzzy open cover of A , is called a finite subcover of $\{\langle x, \mu_{G_i}, \gamma_{G_i} \rangle : i \in J\}$.

(b) An IFS $A = \langle x, \mu_A, \gamma_A \rangle$ in an IFTS (X, τ) is called fuzzy compact if and only if every fuzzy open cover of A has a finite subcover.

COROLLARY 3.6 [7]. *An IFS $A = \langle x, \mu_A, \gamma_A \rangle$ in an IFTS (X, τ) is fuzzy compact if and only if for each family $\delta = \{G_i : i \in J\}$, where $G_i = \langle x, \mu_{G_i}, \gamma_{G_i} \rangle$ ($i \in J$) of IFOs in X with the properties $\mu_A \subseteq \vee_{i \in J} \mu_{G_i}$ and $1 - \gamma_A \subseteq \vee_{i \in J} (1 - \gamma_{G_i})$, there exists a finite subfamily*

$\{G_i : i = 1, 2, \dots, n\}$ of δ such that

$$\mu_A \subseteq \bigvee_{i=1}^n \mu_{G_i}, \quad 1 - \gamma_A \subseteq \bigvee_{i=1}^n (1 - \gamma_{G_i}). \quad (3.1)$$

EXAMPLE 3.7. Let (X, τ_0) be a fuzzy topological space in Chang's sense and $\mu_A \in I^X$ a fuzzy compact set in X . We can construct an IFTS τ on X as in [7, Example 5.9]. Now the IFS $A = \langle x, \mu_A, 1 - \mu_A \rangle$, also fuzzy compact in the IFTS (X, τ) .

COROLLARY 3.8. Let $(X, \tau), (Y, \phi)$ be IFTSs and $f : X \rightarrow Y$ a fuzzy continuous bijection. If A is fuzzy compact in (X, τ) , then so is $f(A)$ in (Y, ϕ) .

For the proof of Corollary 3.8 see [7]. Here we present a version of the Alexander subbase lemma for IFTSs.

PROPOSITION 3.9 (the Alexander subbase lemma). Let δ be a subbase of an IFTS (X, τ) . Then (X, τ) is fuzzy compact if and only if for each family of IFCs chosen from $\delta^c = \{K : K \in \delta\}$ having the FIP there is a nonzero intersection.

PROOF. Let $K = \langle x, \mu_K, \gamma_K \rangle$ denote a typical element in δ^c .

"IF" PART. Straightforward.

"ONLY IF" PART. Suppose, on the contrary, that (X, τ) is not fuzzy compact. Then there exists a family $K = \{\langle x, \mu_{K_i}, \gamma_{K_i} \rangle : i \in J\}$ of IFCs in X having the FIP such that $\bigcap_{i \in J} K_i = 0_-$. The collection of all such families K , ordered by classical inclusion (\subseteq), is inductive. Hence, by Zorn's lemma, we may find a maximal family K , say $M = \{M_j : j \in K\}$, where $M_j = \langle x, \mu_{M_j}, \gamma_{M_j} \rangle$, $j \in K$. The family M satisfies the following properties:

- (1) M is a fuzzy filter consisting of IFCs in (X, τ) ,
- (2) $\bigcap (M \cap \delta^c) = 0_-$.

Now the second assertion gives an immediate contradiction to the hypothesis of the theorem. Hence, (X, τ) is fuzzy compact. \square

4. A Tychonoff theorem in IFTSs. With a Tychonoff-like theorem in mind, we must first present the product of IFTSs. Let (X_i, τ_i) be an IFTS on X_i for each $i \in J$, and let $X = \prod X_i$. For each $i \in J$, we may construct the i th projection mapping as follows:

$$\pi_i : X \rightarrow X_i, \quad \pi_i((x_j)_{j \in J}) = x_i. \quad (4.1)$$

Then we define

$$\mathbf{S} = \{\pi_i^{-1}(S_i) : i \in J, S_i \in \tau_i\}. \quad (4.2)$$

DEFINITION 4.1. The product set X equipped with the IFT generated on X by the family \mathbf{S} is called the product of the IFTSs $\{(X_i, \tau_i) : i \in J\}$.

For each $i \in J$ and for each $S_i \in \tau_i$ we have $\pi_i^{-1}(S_i) \in \tau$; so π_i is indeed a fuzzy continuous function from the product IFTS onto (X_i, τ_i) for all $i \in J$. The product IFT τ is, of course, the coarsest IFT on X having this property.

Now we express Tychonoff theorem in two steps, one of which is valid in general, but its reverse is true for finitely many terms.

THEOREM 4.2. *For each $i \in J$ let (X_i, τ_i) be an IFTS on X_i . Then if the product IFTS (X, τ) is fuzzy compact, then each (X_i, τ_i) is fuzzy compact.*

The proof of [Theorem 4.2](#) follows from [Corollary 3.8](#).

THEOREM 4.3. *Let the IFTSs (X_1, τ_1) and (X_2, τ_2) be fuzzy compact. Then the product IFTS on $X = X_1 \times X_2$ is fuzzy compact, too.*

PROOF. Here we will make use of the Alexander subbase lemma. Suppose, on the contrary, that there exists a family

$$P = \{\pi_1^{-1}(P_{i1}) : i_1 \in J_1\} \cup \{\pi_2^{-1}(P_{i2}) : i_2 \in J_2\} \quad (4.3)$$

consisting of some of the IFCSs obtained from the subbase

$$\delta = \{\pi_1^{-1}(T_1), \pi_2^{-1}(T_2) : T_1 \in \tau_1, T_2 \in \tau_2\} \quad (4.4)$$

of the product IFT on X such that P has the FIP and $\cap P = 0$. Now it can be shown easily that the families

$$P_1 = \{P_{i1} : i_1 \in J_1\}, \quad P_2 = \{P_{i2} : i_2 \in J_2\} \quad (4.5)$$

have the FIP, and since (X_i, τ_i) 's ($i = 1, 2$) are fuzzy compact, we have $\cap P_1 \neq 0$ and $\cap P_2 \neq 0$ which mean that

$$(\wedge \mu_{P_{i1}} \neq 0 \text{ or } \vee \gamma_{P_{i1}} \neq 1), \quad (\wedge \mu_{P_{i2}} \neq 0 \text{ or } \vee \gamma_{P_{i2}} \neq 1). \quad (4.6)$$

But from $\cap P = 0$ we obtain

$$(\wedge \mu_{P_{i1}} \circ \pi_1) \wedge (\wedge \mu_{P_{i2}} \circ \pi_2) = 0, \quad (\vee \gamma_{P_{i1}} \circ \pi_1) \vee (\vee \gamma_{P_{i2}} \circ \pi_2) = 1. \quad (4.7)$$

Here there exist four cases.

CASE 1. If $\wedge \mu_{P_{i1}} \neq 0$ and $\wedge \mu_{P_{i2}} \neq 0$, then there exist $x_1 \in X_1, x_2 \in X_2$ such that $\wedge \mu_{P_{i1}}(x_1) \neq 0$ and $\wedge \mu_{P_{i2}}(x_2) \neq 0$ from which we obtain a contradiction to [\(4.7\)](#), if it is evaluated in (x_1, x_2) .

CASE 2. If $\vee \gamma_{P_{i1}} \neq 1$ and $\vee \gamma_{P_{i2}} \neq 1$, then we get a similar contradiction as in the first case.

CASE 3. If $\wedge \mu_{P_{i1}} \neq 0$ and $\vee \gamma_{P_{i2}} \neq 1$, then there exist $x_1 \in X_1, x_2 \in X_2$ such that $\wedge \mu_{P_{i1}}(x_1) \neq 0$ and $\vee \gamma_{P_{i2}}(x_2) \neq 1$ from which we obtain $\wedge \mu_{P_{i2}}(x_2) = 0$ and $\vee \gamma_{P_{i1}}(x_1) = 1$, and then, since $\gamma_{P_{i1}} \leq 1 - \mu_{P_{i1}}$ for each P_{i1} ,

$$\begin{aligned} \vee \gamma_{P_{i1}} &\leq (1 - \mu_{P_{i1}}) = 1 - \wedge \mu_{P_{i1}} \\ \Rightarrow 1 &= \vee \gamma_{P_{i1}}(x_1) \leq 1 - \wedge \mu_{P_{i1}}(x_1) \\ \Rightarrow \wedge \mu_{P_{i1}}(x_1) &= 0, \end{aligned} \quad (4.8)$$

we obtain a contradiction.

CASE 4. If $\vee y_{pi1} \neq 1$ and $\wedge \mu_{pi2} \neq 0$, then we obtain a similar contradiction as in the third case.

Hence, by the Alexander subbase lemma, (X, τ) is also fuzzy compact. \square

5. Intuitionistic fuzzy dicompactness. First we present a new kind of compactness in IFTSs.

DEFINITION 5.1. Let (X, τ) be an IFTS $K = \{K_i : i \in J\}$, where $K_i = \langle x, \mu_{Ki}, \gamma_{Ki} \rangle$, $i \neq J$, is a family of IFCSSs in X . Then

- (a) K is said to have the finite exclusion property (FEP) if for each finitely many K_1, K_2, \dots, K_n chosen from K there exists $\wedge \mu_{Ki} \leq \vee \gamma_{Ki}$,
- (b) K is said to be bound in (X, τ) if $\wedge \mu_{Ki} \leq \vee \gamma_{Ki}$.

DEFINITION 5.2. An IFTS (X, τ) is called fuzzy dicompact if and only if every family K of IFCSSs in (X, τ) is bound in (X, τ) .

PROPOSITION 5.3 (the Alexander subbase lemma). *Let δ be a subbase of an IFTS (X, τ) . Then (X, τ) is fuzzy dicompact if and only if each family of IFCSSs chosen from $\delta^c = \{G^- : G \in \tau\}$ having the FEP is bound in (X, τ) .*

PROOF. Let $G = \langle x, \cdot \mu_G, \gamma_G \rangle$ denote a typical element in δ .

“IF” PART. This is straightforward.

“ONLY IF” PART. Suppose, on the contrary, that (X, τ) is not fuzzy dicompact. Then there exists a family $K = \{\langle x, \mu_{Ki}, \gamma_{Ki} \rangle : i \in J\}$ of IFCSSs in X having the FEP such that $\wedge_{i \in J} \mu_{Ki} \leq \vee_{i \in J} \gamma_{Ki}$.

The collection of all such families K , ordered by classical inclusion (\subseteq), is inductive. Hence, by Zorn’s lemma, we may find a maximal family K , say $M = \{\langle x, \mu_{Mi}, \gamma_{Mi} \rangle : i \in J\}$. The family M satisfies the following properties:

- (1) $\mathbf{F} = \{\gamma_{Mi} : i \in J\}$ is a fuzzy filter in (X, τ_2) ,
- (2) $\mathbf{G} = \{\mu_{Mi} : i \in J\}$ is a fuzzy filter in (X, τ_1) ,
- (3) $\wedge (\mathbf{F} \cap \{\gamma_G : G \in \delta\}) \leq \vee (\mathbf{G} \cap \{\mu_G : G \in \delta\})$.

Now the third assertion gives an immediate contradiction to the hypothesis of the theorem. Hence, (X, τ) is fuzzy dicompact. \square

Here we state that fuzzy dicompactness is preserved under a fuzzy continuous bijection.

PROPOSITION 5.4. *Let (X, τ) , (Y, ϕ) be IFTSs and $f : X \rightarrow Y$ a fuzzy continuous bijection. If (X, τ) is fuzzy dicompact, then so is (Y, ϕ) .*

PROOF. Let $K = \{K_i : i \in J\}$, where $K_i = \langle y, \mu_{Ki}, \gamma_{Ki} \rangle$, $i \in J$, be a family of IFCSSs in (Y, ϕ) with the FEP. Now define

$$f^{-1}(K) = \{f^{-1}(K_i) : i \in J\}. \quad (5.1)$$

Then $f^{-1}(K)$ consists of IFCSSs in (X, τ) since f is fuzzy continuous, and furthermore it has the FEP. (Suppose that it does not have the FEP. Hence there exist $i = 1, 2, \dots, n$

such that

$$\bigwedge_{i=1}^n f^{-1}(\mu_{Ki}) \leq \bigvee_{i=1}^n f^{-1}(\gamma_{Ki}). \quad (5.2)$$

Hence $f(\bigwedge_{i=1}^n f^{-1}(\mu_{Ki})) \leq f(\bigvee_{i=1}^n f^{-1}(\gamma_{Ki}))$ implies $\bigwedge_{i=1}^n f(f^{-1}(\mu_{Ki})) \leq \bigvee_{i=1}^n f(f^{-1}(\gamma_{Ki}))$. (Since f is 1-1.) This implies

$$\bigwedge_{i=1}^n \mu_{Ki} \leq \bigvee_{i=1}^n \gamma_{Ki} \quad (\text{since } f \text{ is onto}) \quad (5.3)$$

which is in contradiction with the hypothesis.) Since (X, τ) is fuzzy dcompact, we have $\bigwedge_{i \in j} f^{-1}(\mu_{Ki}) \leq \bigvee_{i \in j} f^{-1}(\gamma_{Ki})$ from which we obtain $f^{-1}(\bigwedge_{i \in j} \mu_{Ki}) = \bigwedge_{i \in j} f^{-1}(\mu_{Ki}) \leq \bigvee_{i \in j} f^{-1}(\gamma_{Ki}) = f^{-1}(\bigvee_{i \in j} \gamma_{Ki})$ implies $\bigwedge_{i \in j} f^{-1}(\mu_{Ki}) \leq (\bigvee_{i \in j} \gamma_{Ki})$, which is an obvious contradiction.

Hence (Y, ϕ) is fuzzy dcompact, too. \square
